## HOW YOUR DATA IS USED BY THE COLLEGE

Your data is used by us for a number of interdependent purposes, including alumni relations, communications and fundraising. These include:

- publications,
- surveys,
- appeals and requests for donations, including research on when and whether particular donations or funding appeals may be of interest to you,
- the promotion of alumni and other College events, and
- the promotion of other services open to our members.

Communications to you may be sent by post, telephone or electronic means, depending on the contact details we hold and the preferences expressed by you. ## WHAT DATA IS HELD BY THE COLLEGE?

Most individual records contain:

- details of your school, College and University education,
- unique personal identifiers (e.g. student number, date of birth), and
- your contact details.

Where provided by you, or provided by the University or obtained from reputable public sources we also record additional information including (but not exclusively):

- event attendance,
- key relationships,
- career highlights,
- financial information relating to your philanthropy,
- personal interests, and
- communication preferences.

Depending on constraints set by you, and which you may change at any time, we may share any of the above categories of data with the University, Cambridge in America, volunteer partners closely related to us and contractors providing services to you on our behalf (e.g. mailing houses for College publications).

The legal basis for processing your personal data is your consent, where you have provided this, and otherwise our legitimate interest. You have the right to withdraw your consent at any time. There is no statutory or contractual requirement for you to provide us with any personal data.
